### **PROFESSIONAL EXPERIENCE:**

#### **JANUARY 2018 – TO-DATE: Senior Consultant:**

I have been nominated as Additional Secretary by the Executive Board of the FOD on ad hoc arrangement since 2018. Also I have been advising the Executive Management Team of HRDC as and when needed especially on CBR and Inclusive Development. I am also providing guidance and supportive supervision as the Line Manager of the Inclusive Development of Children with Physical Disabilities (IDC), a Multi-Year (2017 - 2021) Project being run since January 2017 with support from CBM Nepal.

#### **JANUARY 2013 – Dec 2017: Senior Consultant + Executive Director, FOD / HRDC:**

The FOD, a local NGO has been running the treatment and rehabilitation program under the able leadership of Prof. Ashok K. Banskota. I am employed by the FOD for smooth transition of senior executive roles and responsibilities to the new generation leaders. In this transition process, I am responsible for the roles related to CBR and Outreach and General Secretary (ex-officio) as Senior Consultant / Executive Director of FOD / HRDC.

**DEC 1992 – DEC 2012:**

**Executive Director, Hospital & Rehabilitation Centre for Disabled Children (HRDC) Nepal.**

Main aim of the HRDC is to run medical and rehabilitation services to children with physical disability without any religious or ethnic bias. My major responsibilities as Senior Consultant + Executive Director of HRDC, include the following:

- All aspects of finance, planning, project development, implementation and overall management of HRDC for higher quality work.
- Develop, achieve and sustain a management structure and an efficient system of internal communication and guarantee competent caring service to the pediatric disability population
- Also be responsible for all administrative procedures of HRDC
- Actively promote links with Non-Government Organizations (NGOs) and Governmental Organizations, International NGOs as appropriate and represent HRDC in official dealings.
- I was working with team of experts on research / evaluation of impact to clients (children with physical disabilities) of HRDC.

**SOCIAL WORK:** In addition to the normal work at the Friends of the Disabled (FOD) / Hospital and Rehabilitation Program for children with physical disabilities, I was involved in the following:

- In **2000**, organized the 3<sup>rd</sup> South Asian Regional CBR Network Conference in collaboration with National Network Nepal
- In **1997**, I participated in the 2<sup>nd</sup> South Asian Regional CBR Conference in Dhaka, Bangladesh conducted by National Federation of Persons with Disability (NFOWD), Bangladesh and South Asian Regional CBR Network and presented a paper in “CBR Evaluation” which was been published in the Conference souvenir.
- **2003 – 2007:**  
**Regional Coordinator:** Nominated as the Regional Coordinator in the South Asian Regional Network (SARN) in CBR since November 2003 for a period of 3 years to begin. "SARN in CBR" is established and functional with the purpose of facilitating information exchange, sharing experience and organizing platforms to skill / knowledge enhancement and social marketing.

  - b. In **2003**, participated and functioned as Chairman in plenary as well in a concurrent session in CBR in the Regional Symposium in Disability in Dhaka, Bangladesh

**Advisor, CBR National Network Nepal:** I have been functioning as the Advisor for this umbrella organization of organizations working in prevention / rehabilitation of persons with disabilities, inclusion and rights.

**1998 - 2002:**

**National Coordinator, CBR National Network Nepal:** It is an umbrella organization of organizations working in community empowerment, awareness, prevention of disability and rehabilitation of persons with disabilities:

- a. Coordinated disability / CBR national conferences & conducted them six monthly.
- b. Coordinated series of two days long GO – NGOs Conference for mapping disabilities in health personnel.
- c. Played major role in formulating National CBR Strategy in Nepal
- d. Edited and published several "CBR News Bulletins"
- e. Organized the 3 day long Third South Asian Regional Conference in CBR in November 2000 as the Coordinator of the Conference.
- f. Presented a Paper on " Status of Disability in Nepal" jointly with Under Secretary of the Ministry of Women, Children and Social Welfare in the Third South Asian Regional Conference

**CBR Expert in "Disabled Services National Coordination Committee":** In 1999, through ministerial decision I was nominated as CBR Expert by the Ministry of Women, Children and Social Welfare, HMG Government in "Disabled Services National Coordination Committee" for a period of 4 years. The Committee consists of 24 members from Secretaries of different Ministries, Representatives from Disabled Person's Organizations, Representatives from Non-Government Organizations involved in disability management, Social Workers and representatives from other sectors and is led by the Minister of "Women, Children and Social Welfare". The national apex committee was supporting the Ministry to organize disability – prevention and rehabilitation activities, assist the Ministry on legal and other activities related to disability management:

- a. Participated in all Committee meetings
- b. Prepared a discussion paper on National Coordination in disability issues and presented to the Ministers of Women, Children and Social Welfare, Secretaries from different Ministries, Representatives from Self-Help Organization, Social Workers and NGO Representatives in 2002.

**1995 - 1997:**

**CBR National Network Nepal, Executive Member.** As the Executive Member, I was involved extensively in creating platforms for teaching learning exchanges, information dissemination in prevention and rehabilitation of disability, sharing experiences, etc. The major activities included the following:

- Participated and conducted sessions in 6 monthly National Conference organized by CBR National Network Nepal: "Quality Concerns" in CBR, "Non-Profit Management", etc.
- Conducted Session on "CBR Program Evaluation" in the "Second South Asian Regional Conference in CBR" in Dhaka, Bangladesh in Dec 1997.
- Attended several workshops / seminars on: Social Communication Workshop

**JUNE 1990 - NOVEMBER 1992: Chief Administrator, Hospital for Disabled Children (HDC), Jorpati, Kathmandu, Nepal.**

Worked as an Executive Member of the Management Team of the HDC, the main goal of which was rehabilitation of poor children with physical disabilities from disadvantaged families throughout Nepal. My major responsibilities included:

- All aspects of planning, project development and implementation in the capacity of Management Team Member.
- Managed and supervised six non-medical hospital departments.
- Deputy to Expatriate Project Director, handling working relations with some Nepali governmental / non-governmental organizations.
- Responsible, jointly with the Project Director for all administrative procedures including bi-annual staff performance evaluation.
- Reporting monthly on all aspects of the HDC activities to concerned authorities.

**JANUARY 1987 - MAY 1990: Project Director, US Peace Corps, Nepal**

- Developed Pre-Service Training designs for 5 training groups and ensured that the approved designs were implemented. Supervised 30 - 60 people in each training crew. Provided expertise and leadership in counseling trainees and trainers.
- Monitored & evaluated the training programs, performance of personnel and wrote weekly reports.
- Administered the training programs on resources, operational budgets, disbursements, and acted as liaison between Pre-Service Training and the then Nepal Government officials.

**JUNE - DECEMBER 1989: Program Coordinator, US Peace Corps, Nepal**

- Initiated and maintained liaison between Peace Corps / Nepal and key project officials in His Majesty's Government.
- Developed program documentation, procedures and approaches for the General Education, Nursing Education and other prospective programs.

- Advised Training Office on Technical Aspects of Pre-Service Training. Also designed, monitored and evaluated In-Service Training of volunteers.
